Lake Placid is one of the purest lakes on earth. Only 2.5% of the water on earth is fresh water, and of that only 1% is suitable for drinking. Lake Placid is included in that 1% classified as AA-Special, the highest rating for water quality. It is a rare and beautiful resource that must be protected.

Membership Update

To our members, first and foremost, we want to thank you for all that you do for our Lake. Your dues fund the SOA operating budget, which we use to provide all of the services that keep our Lake safe, clean and healthy.

These services are critical to the caretaking of this precious resource, includ-

It is during uncertain and stressful times like these that I am especially grateful for the tranquility and beauty of Lake Placid. I am in Lake Placid now looking out over blowing snow and whitecaps. Gazing over Lake Placid never ceases to thrill me. During the long fall and winter months, you can be assured that the SOA will continue to focus on issues that most impact the purity and enjoyment of our Lake.

During our virtual Annual Meeting in July, you raised questions and concerns about matters that affect the quality of life on Lake Placid. First, was the significant increase in activity on Lake Placid; and second, was our effort to prevent the spread of invasive species. Both are addressed in this Newsletter.

SOA Trustees, Officers and Committee Members have been busy with projects

that will facilitate member communications and strengthen our advocacy for water quality and boater safety. We are upgrading the website; creating a new Shore Owners map and membership list; making needed repairs to the dam; surveying properties owned by the SOA; and working with the Town, Village and DEC on boating safety issues. We also continue to work with the Ausable River Association to complete the Lake Management Plan so we can be more data-driven and proactive in our efforts to protect the Lake.

Climate change, invasive species and increased usage all pose threats to Lake Placid. Yes, our efforts must increase if we hope to preserve Lake Placid for future generations. Thank you to those who have contributed to the charitable funds we manage to protect the Lake. If you

have not already done so, we need your support.

Invasive Species Update

The SOA has increased the effort to control the only invasive species currently in Lake Placid – Variable Leaf Milfoil (VLM).

Our divers harvested VLM twelve days in 2020, up from two days in previous years. These efforts are paying off. Our divers removed 1475 pounds of VLM this summer, a 91% decrease from the 1,675 pounds removed in 2019. This is welcome news after two years of exponential growth. We are still well over the amount of VLM we removed prior to 2018. We will conduct a similar diving program in 2021 to make sure we continue to drive down the amount of VLM in Lake Placid.

These efforts cost approximately \$60,000 to \$70,000 each year. While we apply for grants from the Lake Champlain Basin Program, and request contributions from the Town of North Elba and the Village of Lake Placid, the costs of this program falls primarily on us.

The SOA depends on annual contributions from Shore Owners to protect the Lake from invasive species. In 2019 Shore Owner's contributed a total of \$60,241 to the Invasive Species Prevention Fund. 2020 has been a difficult year. To date, we have received only \$25,800 towards this critical cause. We must increase our giving to the 2019 level to ensure that we have the funds needed to prevent invasive species from clouding the waters of Lake Placid and changing its ecology.

As we Shore Owners know, there are dire consequences for a failure to take persistent action to prevent and control invasive species:

- Water becomes unsuitable for drinking, swimming and boating
- Native plant diversity declines
- Fish and invertebrate populations decline
- Mosquito populations increase
